Campground Rules & Regulations

1. Check in time is 1:00 PM; Check out time is 12:00PM ; Users who check out late will be charged a \$100 fine
2. ATVs and off-road vehicles ARE NOT permitted.
3. All campers will pay current campsite fee at the time of registration.
4. All registered campers will be required to wear wristbands during their stay.
5. Units per campsite; One unit permitted per campsite. Additional unit is permitted at designated rate.
6. Visitors; Those visiting registered campers may do so between 7am and 11pm. After which time all visitors will be asked to leave. A maximum of 2 visiting vehicles per lot will be allowed at any given time.
7. Occupants per campsite; One to six people per lot, with at least one person being 18 years of age or older. During quiet time, those without proper campsite wristbands will be evicted from the campsite grounds.
8. Pets; Dogs and other domestic animals must remain on a leash or other device at all times. Limit of 2 pets per site. Pet owners are responsible for cleaning up after their pets at all times.
9. Fires; Fires are permitted in fire pits only and are subject to fire bans. Firewood is supplied at no cost, please use sparingly.
10. Alcohol; Open alcohol must be kept on campsites. Any traveling between campsites with open beverages or under-age drinking is NOT permitted.
11. Children's Playground; Adult supervision is strongly recommended for younger children. Please use at own risk. Pets are NOT allowed in playground area.
12. Watch & Secure Belongings; The Falher Municipal Campsite or the Campsite Attendant are not responsible for any loss, theft, damage or injury that may occur while staying at or visiting the campground.
13. During daytime hours, excessive noise which causes a disturbance to others will not be tolerated.
14. Food and coolers must NOT be left unattended on a site and must be put away inside a vehicle at night.
15. Failure to comply with campground Rules and Regulations will result in an eviction & eviction fee of \$50 (+tax).
16. Towed evictions will be charged to credit card supplied upon registration at a rate of \$750(+ tax) per unit.
17. Cleaning fees; Should campsite lot be left in a manner requiring attention that is above and beyond a cleaning fee may be charged at a rate of \$350(+tax) per lot.
18. Campground speed limit is 10 km/h
19. Eviction may result in refusal of access to the: (including but not limited to) Falher Regional Recreation Complex, Falher Regional Swimming Pool, Falher Municipal Campground, for up to 3 years.
